REGULATIONS CONCERNING BOARD VALUATION, REJECTION OF
RESULTS AND IMPROVEMENT OF RESULTS-POSTGRADUATE
PROGRAMMES

BOARD VALUATION

Students who wish to apply for Board Valuation can do so by submitting the online application form available on the *StudentConnect* App using their valid login credentials. An online payment of ₹1,800 per course is required. The application must be submitted within the dates as specified in the notification.

REJECTION OF RESULTS

- A candidate who fails in one or more of the papers of a semester may be permitted to reject the result. Rejection of result paper-wise is not permitted. However, a candidate may be permitted to reject the result of the whole of the examination of the concerned semester.
- Rejection shall be exercised only once in each semester and the semester results once rejected shall not be revoked.
- Application for rejection of results along with the payment of the prescribed fee shall be paid within as prescribed in the notification.
- A candidate who rejects the result is eligible for class and not for ranking.
- A candidate who rejects the result of a semester may appear for the examination of the semester concerned (Odd Semester during Odd subsequent Semester examination and Even Semester, during subsequent Even Semester examination or during Supplementary Examinations as notified) by applying with the prescribed fee.

IMPROVEMENT OF RESULTS

- A candidate who passes all the courses/papers of a semester may be permitted to improve the result by reappearing for the whole examination of that semester.
- The reappearance could be permitted twice during double the period of the degree programme without restricting it to subsequent examination only. The Regulation governing the maximum period for completing various degree program notified by St Aloysius (Deemed to be University) from time to time shall be applicable for improvement of results.

- If the candidate passes in all the subjects in the reappearance, higher of the two aggregate marks secured by the candidate shall be awarded to the candidate for that semester. In case the candidate fails in the reappearance, candidate shall retain the first appearance result.
- A candidate who appears for improvement of results is eligible for class and not for ranking.
- Internal assessment marks already obtained shall be retained. No separate internal assessment is allowed for improvement of results.
- A candidate is permitted to take the examination on the same syllabus and scheme up to double the duration of the degree programme.
- The candidate who rejects the result shall surrender the marks card of the semester concerned already issued.
- The candidate appearing for the improvement of results shall surrender the marks card already issued, degree certificate, if issued and other relevant documents.
- The fee for rejection of the result is ₹ 3,000 per semester.
- The fee for improvement of the result is ₹ 3,000 per semester.
- Candidates appearing for subsequent examination after rejecting the results shall pay the whole examination fee prescribed from time to time.
- Candidates appearing for subsequent examination for improvement of results shall pay the whole examination fee prescribed from time to time.
